FOR YOUR SAFETY AND ENJOYMENT
WE ASK THAT YOU OBSERVE AND FOLLOW THE PARK RULES

PARK HOURS
8:00 AM TO SUNSET

- **DOGS MUST BE KEPT ON LEASH AND UNDER OWNER CONTROL AT ALL TIMES. NO DOGS ALLOWED ON THE BEACH OR IN SWIM AREAS**
- **DOG OWNERS ARE REQUIRED TO CLEAN UP AND DISPOSE OF DOGS WASTE**
- **NO KITEBOARDING OR KITE TRAINING. NO MULTILINE KITES OR KITES WITH BAR ARE ALLOWED IN PARK**
- **PLEASE RIG AND STORE SAILBOARD, SUP, OR KAYAK IN DESIGNATED RIGGING AREA ONLY (NE CORNER OF PARK)**
- **LITTER MUST BE PLACED IN RECEPTICLES, OR "PACK IT IN, PACK IT OUT"**
- **HOUSEHOLD AND COMMERCIAL GARBAGE DUMPIN IS PROHIBITED.**
- **NO OVERNIGHT CAMPING OR PARKING**
- **MOTOR VEHICLES ARE PROHIBITED IN PARK EXCEPT AUTHORIZED CITY VEHICLES**
- **CUTTING, PICKING, REMOVAL AND DESTRUCITON OF PLANT LIFE OR PROPERTY IS PROHIBITED**
- **DO NOT CLIMB TREES. DO NOT SKATE ON WALLS OR FURNISHINGS**
- **FIREWORKS AND OPEN FLAMES ARE PROHIBITED**
- **BICYCLING OR SKATING: PROPER SAFETY EQUIPMENT MUST BE WORN**

PLAYGROUND HOURS 8:00 AM TO SUNSET

- **PLAY SAFE AND RESPECT OTHER USERS**
- **ADULT SUPERVISION IS REQUIRED FOR CHILDREN UNDER AGE OF 12**
- **DOGS MUST BE KEPT ON LEASH AND UNDER OWNER CONTROL AT ALL TIMES.**
- **DOG OWNERS ARE REQUIRED TO CLEAN UP AND DISPOSE OF DOGS WASTE**
- **THE FOLLOWING ARE NOT ALLOWED IN THE PLAYGROUND AREA:**
 - ✓ **ATHLETIC CLEATS OR SPIKES OF ANY KIND**
 - ✓ **WOMEN'S HIGH HEELS**
 - ✓ **WOODEN OR METAL BATS**
 - ✓ **HARD BALLS SUCH AS BASEBALLS, GOLF BALLS, ETC.**
 - ✓ **ROLLER BLADES, ROLLER SKATES, OR SKATEBOARDS**
 - ✓ **BICYCLES MUST NOT BE LAID ON THE GROUND IN THE PLAYGROUND, PLEASE USE THE BIKE RACKS TO SECURE YOUR BICYCLES**
- **USE PLAYGROUND EQUIPMENT FOR THE USE IT IS INTENDED**
- **PLEASE RIG AND STORE SAILBOARD, SUP, OR KAYAK IN DESIGNATED RIGGING AREA ONLY (NE CORNER OF PARK)**

PICNIC SHELTER HOURS
8:00 AM TO SUNSET

- PICNIC SHELTER IS "FIRST COME; FIRST SERVE" RULE UNLESS RESERVED
- PICNIC SHELTER MAY BE RESERVED DAILY
- **"DROP IN" GROUPS/EVENTS MUST VACATE IN THE EVENT THE PICNIC SHELTER HAS BEEN OFFICIALLY RESERVED**
- LITTER MUST BE PLACED IN RECEPTICLES, OR "PACK IT IN, PACK IT OUT"
- OPEN FLAMES ARE PROHIBITED. ONLY GRILLS ARE TO BE USED.
- **SKATE BOARDING ON WALLS OR FURNISHINGS PROHIBITED**
- FOR RESERVATIONS AND INFORMATION CALL CITY PUBLIC WORKS AT 541-387-5201 DURING NORMAL BUSINESS HOURS

SWIM BEACH RULES

BEACH HOURS
8:00 AM TO SUNSET

- **NO LIFEGUARD ON DUTY. SWIM AT YOUR OWN RISK**
- **NO DOGS ALLOWED ON THE BEACH OR IN SWIM AREAS**
- **NO KAYAKS, KITEBOARDS, OR WINDSURFING IN SWIM AREA**
- **PLEASE RIG AND STORE SAILBOARD, SUP, OR KAYAK IN DESIGNATED RIGGING AREA ONLY (NE CORNER OF PARK)**
- **NO RADIO CONTROLLED BOATS IN SWIM AREA**
- **NO MOTOR POWERED CRAFT OR ELECTRIC TROLLING MOTORS ALLOWED IN SWIM AREA**
- **NO OVERNIGHT CAMPING**
- **FIREWORKS AND OPEN FLAMES ARE PROHIBITED**
- **LITTER MUST BE PLACED IN RECEPTICLES, OR "PACK IT IN, PACK IT OUT"**
- **NO GLASS CONTAINERS ON BEACH OR IN SWIM AREA**
